DEMO PRODUCT LIABILITY AGREEMENT

1. Blake Medical Distribution is hereby authorizing _____ to use our _____ as a demonstration product.
2. All Demonstration equipment is to be on loan for a term no longer than 30 days.
3. Blake Medical must be **made aware** of any contagious illnesses that the client requesting the demonstration product has. This information is required before the product will be shipped as they may not qualify for demonstration products. If your client has incontinence issues Blake Medical must be made aware to ensure extra protection is provided with the demonstration product. If Blake Medical is not notified for any of the concerns stated, your company may be charged if product is no longer usable due to damage or infection.
 - i. If your client has a contagious illness, please check here.
 - ii. If extra incontinence protection is required, please check here.
4. Demo requisitions may be denied, if the clients place of residence contains pests. Blake Medical must be **made aware** of these circumstances before demo product will be released. If Blake medical receives returned demonstration products that contain pests, your company will be liable for any fees or costs incurred by Blake Medical associated with the extermination of pests or related issues. Furthermore, your company will be invoiced for the unusable product. Pests include but are not limited to bedbugs, cockroaches, silverfish, and fleas.
 - i. If client's residence contains pests, please check here.
5. Should you return the demo product within the 30 day term you will require a Return Authorization number. Please contact the office to get this number. You will not be billed.
6. If the demonstration product has not been returned or had a Return Authorization number assigned within the 30 day term the item is considered **non-returnable** and **non-refundable**. Your demonstration product is now considered purchased and an invoice will be issued.
7. **Once your RA# has been issued, our product is expected to be shipped out from your location within 5 business days.** If we contact you to find out where our package is and it has not been shipped within the allotted time then it is considered sold. You will be invoiced for the product.
8. Your company is responsible for any Shipping and Handling fees for items being purchased or returned to Blake Medical.
9. Please note that all our demonstration products are Standard Sizes. Custom Demonstration Products will not be provided for Demonstration use, unless otherwise specified.
